**ARTICLES OF ORGANIZATION
OF
LOGGING HORSE INVESTMENT CAPITAL, LLC
a Florida limited liability company**

Pursuant to the provisions of Chapter 605, Florida Statutes, this Florida profit limited liability company adopts the following Articles of Organization:

ARTICLE I

The name of the limited liability company is **LOGGING HORSE INVESTMENT CAPITAL, LLC**.

ARTICLE II

The period of existence of the limited liability company shall be perpetual, commencing on the date the original Articles were filed.

ARTICLE VII

The Interests of the current Members shall be evidenced by Certificates, which shall be issued by the corporation reflecting the percentage interest held by the Members.

ARTICLE VIII

The Operating Agreement between the Manager Member and the Company shall be adopted by the Members. Thereafter, the power to alter, amend, or repeal the Operating Agreement shall be vested in the Members of the Company in the manner set forth in the Operating Agreement; provided, however, that the consent of the Manager Member shall be required before any amendment, alteration or repeal of the Operating Agreement.
