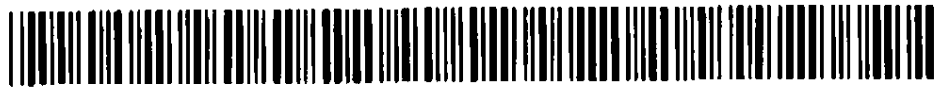




ARTICLE VII
