

ARTICLES OF ORGANIZATION
OF
JACKIE'S QUILT CENTRAL, LLC
A FLORIDA LIMITED LIABILITY COMPANY

The undersigned does hereby execute these Articles of Organization for the purpose of forming a limited liability company under the laws of the State of Florida.

ARTICLE I--NAME

The name of the limited liability company is Jackie's Quilt Central, LLC ("Company").

ARTICLE II--PERIOD OF DURATION

The period of duration of the Company shall be perpetual.

ARTICLE III--PURPOSES

The Company may engage in the transaction of any or all lawful business for which limited liability companies may be formed under the laws of the State of Florida.

ARTICLE IV--ADDRESS AND PLACE OF BUSINESS

The mailing address of the Company is 832 Willow Creek Lane, Melbourne, FL 32940, and the street address of the principal office in Florida is 832 Willow Creek Lane, Melbourne, FL 32940.

ARTICLE V--REGISTERED AGENT/OFFICE

The name of the initial registered agent of the Company is William J. Kananack, Esq., of Kananack Law LLC, and the street address of the Company's initial registered office is 100 Rialto Place, Suite 700, Melbourne, FL 32901.

The Company may change its registered office or its registered agent, or both, by filing a statement with the Florida Department of State in accordance with Section 605 of the Florida Statutes.

ARTICLE VI--MANAGEMENT

All powers of the Company shall be managed by or under the authority of, and the business and affairs of the Company shall be managed by or under the direction of the Board of Managers of the Company. The Board of Managers shall consist of one (1) person elected in the manner prescribed in the Operating Agreement. The name and address of the manager serving as the initial authorized member manager (AMBR) until the first annual meeting of members and until her successor or successors are elected and qualify is as follows:

ARTICLE VII--RESTRICTIONS ON MEMBERSHIP

New members shall be admitted to the Company upon approval of the Board of Managers, or as otherwise provided in the Operating Agreement of the Company. Contributions required of a new member shall be determined by the Board of Managers as of the time of the admission of the new member. A member's interest in the Company may not be sold or otherwise transferred except in accordance with the Operating Agreement of the Company.


ARTICLE VIII--ACCEPTANCE BY REGISTERED AGENT/SIGNATURE OF REGISTERED AGENT
