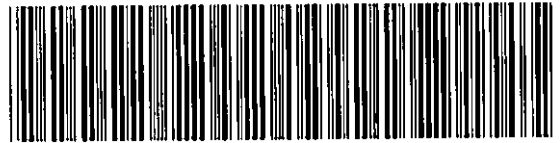

ARTICLE VII - ORGANIZING MEMBERS




