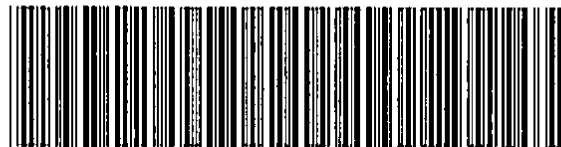



FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE WITH MINOR CHILD(REN)
(UNCONTESTED)

THIS CAUSE, having come on to be heard before this Court on Husband's Petition for Dissolution of Marriage with Minor Children and the Court, having reviewed the pleadings in this cause, and on the evidence presented makes these findings of fact and reaches these conclusions of law:

FINDINGS:

1. This Court has jurisdiction over the subject matter and the parties.
2. Both parties have been residents of the State of Florida for more than 6 months immediately before filing the Petition for Dissolution of Marriage.
3. The name of the parties' child is as follows:

C.L.H. Birth date: 08/28/2012
4. The marriage between the parties is irretrievably broken.
5. The parties have voluntarily entered into a Marital Settlement Agreement and Parenting Plan dated December 6, 2021, and each party has filed the required Family Law Financial Affidavit. The Parenting Plan is in the best interests of the children. The Marital Settlement

Agreement and the Parenting Plan were previously filed with this Court.

6. The Court finds that the parties have the present ability to pay support as agreed to in the Marital Settlement Agreement.
7. Respondent requests that her former name of Estephanie Soto be restored.

ORDERED AND ADJUDGED:

- A. The marriage between the parties is dissolved and the parties are restored to the status of being single.
- B. The Marital Settlement Agreement and Parenting Plan dated December 6, 2021, which was previously filed with the Court, is hereby ratified, approved, and incorporated into this Final Judgment by reference but shall not be merged with Final Judgment, and the parties are hereby ordered to comply with all of the terms and provisions contained therein.
- C. Respondent's former name of Estephanie Soto is restored.
- D. The Court reserves jurisdiction to modify and enforce this final judgment.

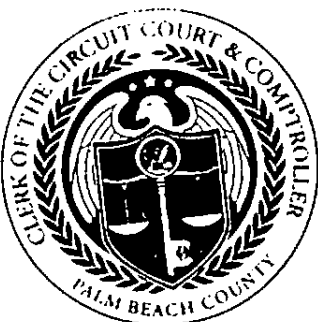
