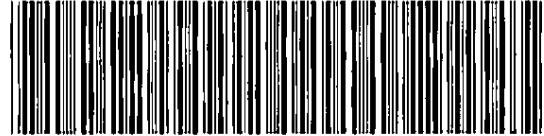

**Name**


*The name of the Limited Liability Company is **P Dynasty Investments LLC**.*
