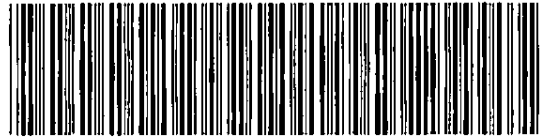

Patrick Voltapetti is relinquishing his 50% stake in PV&KM Holdings, LLC to Katherine Moreno.


