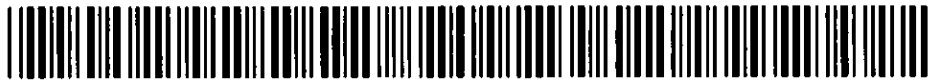


ARTICLE IV
