The undersigned, AMY HENDERSON PALMER NITTI, a natural person competent to contract and an authorized representative of CRIMSON SWEATER, LLC, hereby presents these Articles of Organization as the Articles of Organization of CRIMSON SWEATER, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is CRIMSON SWEATER, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

The date for commencement of the Company's existence shall be October 6, 2021. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.


**ARTICLE V - REGISTERED OFFICE AND AGENT**


