

ARTICLES OF ORGANIZATION OF CRIMSON SWEATER, LLC

The undersigned, AMY HENDERSON PALMER NITTI, a natural person competent to contract and an authorized representative of CRIMSON SWEATER, LLC, hereby presents these Articles of Organization as the Articles of Organization of CRIMSON SWEATER, LLC, a limited liability company formed under the provisions of Chapter 605, Florida Statutes.

ARTICLE 1 - NAME
