(a) Manager's Unanimous Authority. 

IN WITNESS WHEREOF, the undersigned, the Authorized Representative of the Company, has signed these Articles of Organization on October 7, 2021.



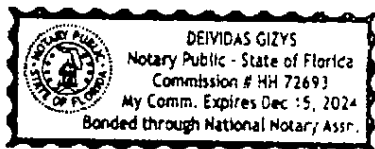


