**ARTICLES OF ORGANIZATION  
OF AUNT JENNIE'S LEGACY, LLC  
a Florida limited liability company**

The undersigned, ANGELA KYLE, competent to contract and an authorized representative of AUNT JENNIE'S LEGACY, LLC, hereby presents these Articles of Organization as the Articles of Organization of AUNT JENNIE'S LEGACY, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is AUNT JENNIE'S LEGACY, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The initial mailing address and principal address of the Company is 4910 Lynell Street, Pensacola, Florida 32503. The Company's mailing address and principal office may hereafter be at such other place or places as its members from time to time may determine.

**ARTICLE III - PURPOSE AND POWERS**


