NAME

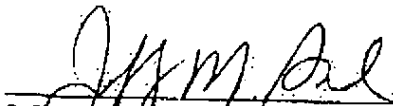
ARTICLE VII

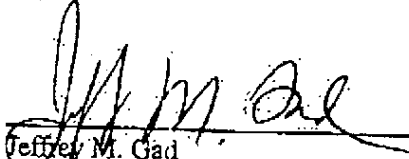
