- On October 14, 2021, Albert Meyer filed Articles of 2. Organization of Sarasota Comprehensive Endocrine Clinic, LLC ("SCEC") with the Department of State, Division of Corporations, improperly listing me as the member of SCEC and 2400 Fruitville Rd., Sarasota, FL 34237 as the principal address for this entity.
- In October of 2021, I had never heard of SCEC and never agreed to be appointed as its member.
- Moreover, as of October 14, 2021, the listed address was the principal address of my former practice Antunes, M.D., P.A., and I had never agreed to listing this address as the principal address of another entity (of which I had no knowledge).
- 5. On February 20, 2023, I filed a claim against SCEC, seeking a judicial declaration as to my affiliation with or status vis-à-vis SCEC.
- On April 26, 2024, Final Judgment has been entered declaring that my purported affiliation with and member status at SCEC is null and void ab initio. A copy of the Final Judgement is attached hereto as Exhibit "A."



- C. The Court reserves jurisdiction to award costs or attorney fees or both upon a timely motion; and
- D. The Court further reserves jurisdiction to enter any and all orders necessary to enforce this Judgment.
