ARTICLES OF ORGANIZATION OF K&K 30A HOLDINGS, LLC

The undersigned, Kirk Kimler, a natural person competent to contract and an authorized representative of K&K 30A Holdings, LLC, hereby presents these Articles of Organization as the Articles of Organization of K&K 30A Holdings, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

<u>ARTICLE I – NAME</u>

The name of the limited liability company is K&K 30A Holdings, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

<u>ARTICLE II – PRINCIPAL OFFICE ADDRESS</u>
