**ARTICLES OF ORGANIZATION

The undersigned, Kathleen A. Richardson, a natural person competent to contract and an authorized representative of WillyKat, LLC, hereby presents these Articles of Organization as the Articles of Organization of WillyKat, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is WillyKat, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The initial principal address and mailing address of the Company is 141 Bayshore Drive, Pensacola, Florida 32507. The Company's mailing address and principal office may hereafter be at such other place or places as its members from time to time may determine.

**ARTICLE III - PURPOSE AND POWERS**

**ARTICLE VI - MANAGEMENT**

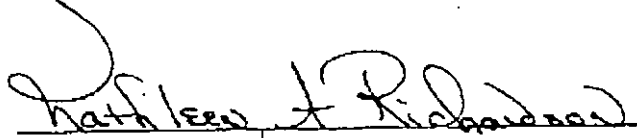
