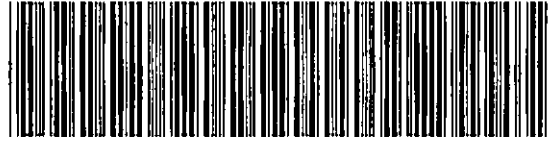

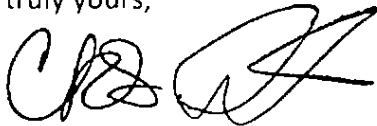

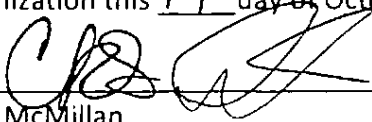
ARTICLE VIII – TRANSFER RESTRICTION

The Limited Liability Company is to be managed by one or more managers who are also members and is, therefore, a member – managed company.

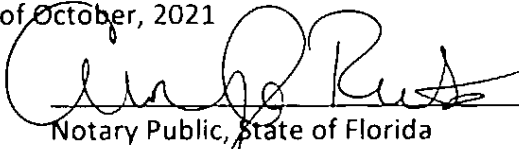

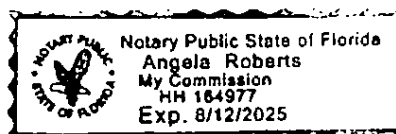
