ARTICLES OF ORGANIZATION
of
235 LAKE VISTA CIRCLE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be 235 Lake Vista Circle, LLC (the "*Company*"). The mailing and street address of the principal office of the Company shall be 3531 Beauclerc Circle North, Jacksonville, Florida 32257.

ARTICLE II

PURPOSES AND POWERS

DURATION AND COMMENCEMENT


