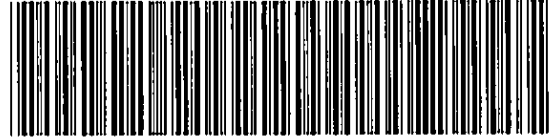

**ARTICLES OF ORGANIZATION

Registered Agent and Office**

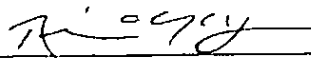

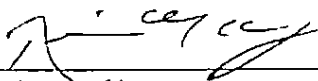
