

**ARTICLES OF ORGANIZATION
OF
IAROSSI RACING, LLC**

The undersigned authorized representative of one or more members, for the purpose of forming a limited liability company ("Company") pursuant to the Laws of the State of Florida, and particularly Chapter 605, Florida Statutes, hereby submits the following Articles of Organization:

Article 1
Name

The name of the Company shall be IAROSSI RACING, LLC. These Articles of Organization may be referred to as the "Articles", and the Operating Agreement of the Company may be referred to as the "Operating Agreement."

Article 2
Office

The initial principal office and mailing address of the Company shall be 124 West Jefferson Street, Tallahassee, Florida 32301. The Company may designate such alternate place of business according to procedures for Company action as set forth in its Operating Agreement. Books and records of the Company shall be kept at its principal office or at such other place as may be permitted by law.

Article 3
Purpose

The Company is organized to engage in any and all business permitted under the Laws of Florida and other jurisdictions, including but not limited to the business of owning and/or operating a race care, management of sponsorship money and the operation of all related business interests.

Article 4
Powers

The Company shall have all of the common law and statutory powers of a limited liability company under the Laws of Florida, except as expressly limited or restricted by the terms of these Articles or the Operating Agreement, and all of the powers and duties reasonably necessary to operate the Company pursuant to the Operating Agreement, as it may be amended from time to time.

Article 5
Term of Existence

The Company shall have perpetual existence.






