### The Cornerstone of Paradise

It was customary for the King to fold his napkin and place it on the table at the right side of the table, indicating that he would return. "And he saw the linen cloths lying there, and the handkerchief that had been around His head, not lying on the ground with the other cloths, but folded together in a place by itself" (John 20:6,7)

The Magi brought with them gifts of gold, frankincense, and myrrh. Gold for His financial support, and rare oils for His burial. In this package are the Cornerstone, some have holes or "portals," anointing oil infused with frankincense and myrrh, and a folded white napkin. The Holy Spirit also inspired the logo. It combines the shepherd's staff, cross, sword, Alpha, and Omega, all that is Jesus Christ our Lord and Savior.
