**ARTICLES OF ORGANIZATION
OF ROMANA COTTAGE LLC
a Florida limited liability company**

The undersigned, RICHARD N. SHERRILL, competent to contract and an authorized representative of ROMANA COTTAGE LLC, hereby presents these Articles of Organization as the Articles of Organization of ROMANA COTTAGE LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is ROMANA COTTAGE LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS
