ARTICLE IX – TERMINATION OF EXISTENCE




ARTICLE X – MEMBERS

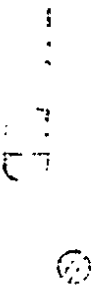


