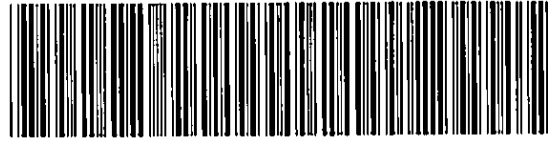

The mailing address and street address of the principal office of the Company is: 2281 Griffin Road, Fort Lauderdale, FL 33312.


