FIRST: The Articles of Organization for the Company were filed on October 28, 2021 and assigned Florida Document number L21000466638.


SECOND: The Company desires to change its name from Capital Vet Holdings, LLC to:



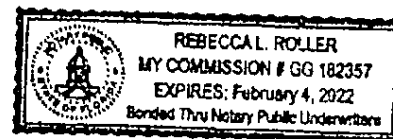
