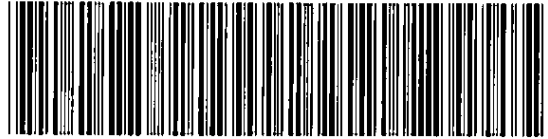



The mailing address and street address of the principal office of the Company shall be 1601 McCloskey Blvd, Tampa, FL 33605.




