
On 19. October 2021, I mistakenly incorporated a business name instead of making it an LLC.

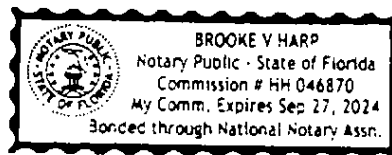
