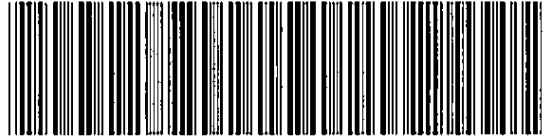

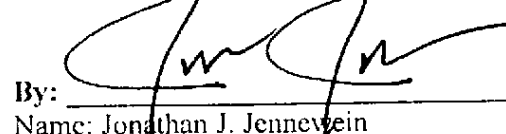

The name of the limited liability company is Jennewein Enterprises, LLC.

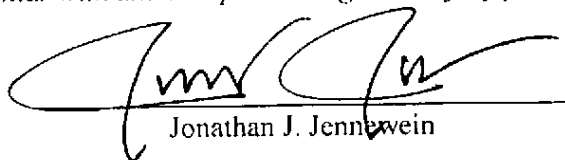
ARTICLE II. ADDRESS

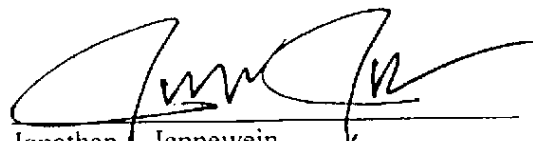
