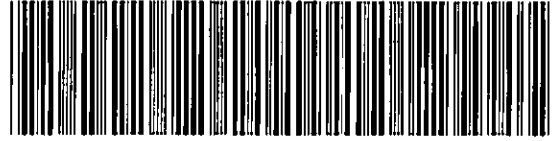

**THIRD:** The mailing and street address of the principal office of the Limited Liability Company is 8147 Whistlewing Court, Orlando, FL 32817.




