The Articles of Organization of SK7 Holdings, LLC (the "Company"), were filed with the Florida Department of State, Division of Corporations on November 5, 2021. In accordance with the provisions of Section 605.0202, Florida Statutes, these Amended and Restated Articles of Organization have been duly executed and are being filed to amend and restate in their entirety all prior Articles of Organization filed on behalf of the Company. The Company's Amended and Restated Articles of Organization are as follows:

ARTICLE I

The name of this limited liability company shall be: SK7 Holdings, LLC

ARTICLE II

The street address of the principal office of the limited liability company shall be 5030 Champion Blvd., Suite G11-281, Boca Raton, Florida 33496, with the privilege of having its offices and branch offices at other places within or without the State of Florida.

ARTICLE III

The initial registered office of this limited liability company is 5030 Champion Blvd., Suite G11-281, Boca Raton, Florida 33496. The initial registered agent at that address is PG Law, PL.

ARTICLE IV


The limited liability company will be a manager-managed limited liability company, and management of the limited liability company will be vested in its managers. The initial manager of the limited liability company is SK7 Manager, LLC, a Florida limited liability company.
