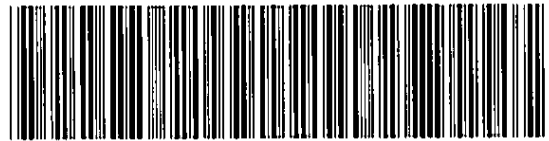

**ARTICLES OF ORGANIZATION FOR

ARTICLE VI - Members Rights to Continue Business


