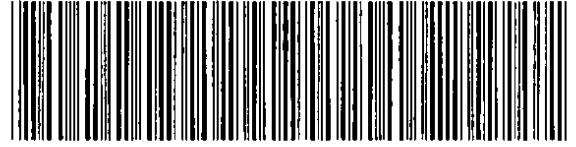


STATEMENT OF TERMINATION
