**ARTICLES OF ORGANIZATION
OF

Pursuant to the provisions of Chapter 605, Florida Statutes, this Florida profit limited liability company adopts the following Articles of Organization:

ARTICLE I

The name of the limited liability company is **Coral Plaza ALF, LLC**.

The period of existence of the limited liability company shall be perpetual, commencing on the date the original Articles were filed.

Thereafter, the power to alter, amend, or repeal the Operating Agreement shall be vested in the Members of the Company in the manner set forth in the Operating Agreement; provided, however, that the consent of the Managing Entity shall be required before any amendment, alteration or repeal of the Operating Agreement.
