FIFTH: This limited liability company shall exist until dissolved in a manner provided by law, or as provided in the regulations adopted by the members.



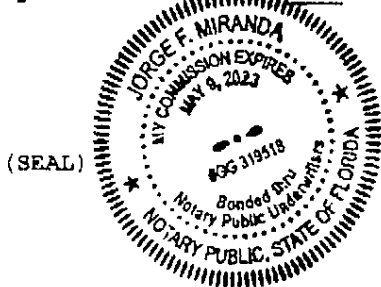
