Pursuant to the provisions of section 605.0209 Florida Statutes, this document is being submitted to correct the Articles of Organization of FGQOZB, LLC:

FIRST: The name of this Florida limited liability company is FGQOZB, LLC (the "Company").

SECOND: The Articles of Organization of the Company were filed with the Florida Department of State on November 9, 2021 and assigned Document Number L21000479826.

THIRD: Article 3 of the Articles of Organization incorrectly reflected the purpose of the Company.

FOURTH: Article 3, as corrected, states as follows:

**"ARTICLE 3
NATURE OF BUSINESS**

The purpose of the Company shall be to qualify as a "qualified opportunity zone business" under Section 1400Z-2 of the Internal Revenue Code of 1986, as amended (the "Code") and to, directly or indirectly, through the Company and one or more subsidiaries, identify, source, acquire, originate, maintain, own, manage, finance, refinance, sell, hold, reposition, pledge, hypothecate, hedge, exchange, and otherwise deal with or use assets in order to conduct business as a "qualified opportunity zone business" as defined by Section 1400Z-2 of the Code. The "qualified opportunity zone business" is expected to involve the use of real estate located in Palm Beach County, Florida, in such a way that the Company qualifies as a "qualified opportunity zone business" under Section 1400Z-2(d) of the Code. The Company shall have the power and authority to conduct any and all activities related or incidental to the purpose of qualifying as a "qualified opportunity zone business" under Section 1400Z-2 of the Code."
