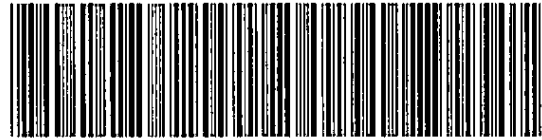

The initial registered agent is William Dale Dubberly. The registered agent may be changed at any time by a majority vote of the members without an amendment to these Articles.





