ARTICLES OF ORGANIZATION OF SIGNATURE TITLE OF FL. LLC

SECTION 1 INTRODUCTION AND PRELIMINARY STATEMENTS

The undersigned Organizer desires to form a limited liability company under the Laws of the State of Florida by delivering these Articles of Organization to the State of Florida Division of Corporations, in accordance with Chapter 605 Florida Revised Limited Liability Company Act (the Act). 2021 NOV 55

SECTION 2 NAME

The name of the limited liability company is Signature Title of FL, LLC, a Florida limited liability company (Company).

SECTION 3 DURATION

The Company will perpetually exist from the filing date of these Articles of Organization with thee Division of Corporations, unless dissolved according to law.

SECTION 4 COMPANY'S PURPOSE

The Company's purpose is to engage in any lawful act or activity for which limited liability companies may be formed under the Act and all activities necessary or incidental to that purpose. The Company has all the powers necessary or convenient to carry out its purposes, including the powers granted by the Act.

COMPANY'S PRINCIPAL OFFICE AND LOCATION OF RECORDS SECTION 5

SECTION 8 ADDITIONAL MEMBERS

The Company has the right to admit additional Members to the Company under the terms and conditions of the Company's Operating Agreement. Any Member who is later admitted as a Member of the Company will have all of the rights and obligations of an original Member under the Operating Agreement. Any transferee of a Member's Interest in the Company must be treated as an Assignee until that transferee is admitted as an Additional or Substitute Member, if ever, under the Operating Agreement.

SECTION 9 OPERATING AGREEMENT AND AUTHORITY

To the extent not expressly required by and provided for in the Act, the manner in which the Company conducts its business and affairs, the duties and authority of its Members and Managers, and the rights and obligations of its Members and Managers must be set forth in the Operating Agreement adopted by the initial Members and Managers of the Company. SECTION 10 MANAGEMENT
