**ARTICLES OF ORGANIZATION
OF
QUINJET I, LLC**

ARTICLE VI – MANAGEMENT



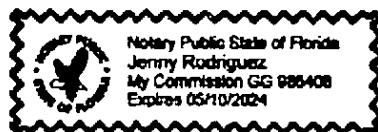


