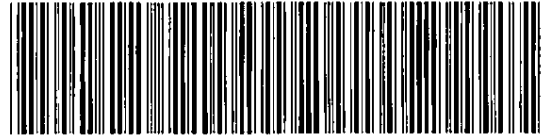

**Registered Agent**

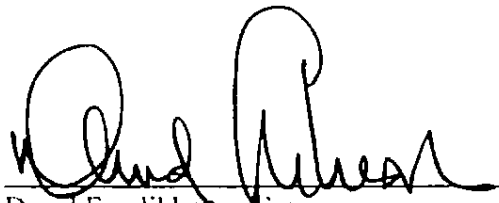
