The name of the limited liability company is: CLF TWO, LLC.

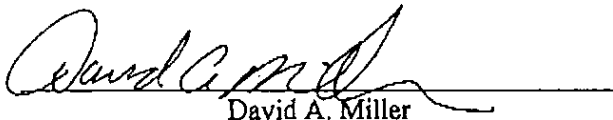
ARTICLE II. ADDRESS
