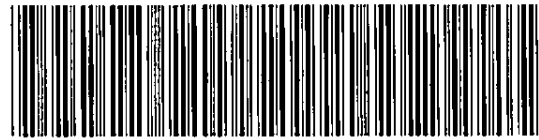

This Limited Liability Company may engage in any activity or business permitted under the laws of the State of Florida.


**ARTICLE VI**


