The undersigned, ROGER ORTH JR., a natural person competent to contract and an authorized representative of Texar Investment Trust LLC, hereby presents these Articles of Organization as the Articles of Organization of Texar Investment Trust LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME
