## DECLARATION OF ALAN ANDRZEJEWSKI

Alan Andrzejewski, pursuant to 28 U.S.C. § 1746, hereby declares that the following is true:

- I am over 18 years of age, of sound mind, and otherwise competent to make this
   Declaration. The evidence set out herein is based on my personal knowledge.
- 2. I am currently a resident of Hartwell, Georgia and was hired on or about May of 2021 to work for Free Speech Foundation (FSF), d/b/a/ Americas Frontline Doctors ("AFLDS") to serve as their Security, Logistics and Procurement Director. I continue to work for AFLDS and.
- 3. I have 35 years of law enforcement experience and six (6) years active duty in the United States Army as a Military Police Dog Handler. I retired from the DeKalb County Police Department (near Atlanta, Georgia), as a Captain. The department had approximately 1,100 officers. I received over 75 commendations, including officer and supervisor of the year.
- 4. I held the following positions during my career: Assistant Precinct Commander.

  Precinct Commander, SWAT/K9 Commander, Training Division Commander, Honor Guard

  Commander, Special Investigations Commander (HIDTA—DEA Federal Drug Task Force), Youth

  & Sex Crimes Detective, Under Cover Narcotics Detective, Uniform Division Patrol Officer, and

  Supervisor over the Street Level Drug Task Force.
- 5. During my tenure at AFLDS, I have worked for and have only reported to and only taken direction from Dr. Simone Gold as the Founder, President and Chairman of the Board of AFLDS/FSF. I have used all of my decades of professional training and experience as an officer and detective to review the evidence in this litigation.
  - 6. I have personal knowledge of matters related to Naples Freedom Headquarters and have been its manager since November 24, 2021. I have also been the registered agent since its inception in November 24, 2021. Part of my job responsibility is updating annual reports with Florida Department of State's Division of Corporations. This includes Naples Freedom HQ and Free Speech Foundation. To assist me with the corporate filings and registered agent

responsibilities I contracted Northwest Registered Agents (NWRA) of 7901 4th St N St. Petersburg, FI 33702 to manage these filings.

- 7. On or about January of 2024 I received a notice from NWRA reminding me of the upcoming annual report renewal and offering their assistance on same. I proceeded to file the annual report myself as usual and did not reply to NWRA. I confirmed the annual report filing to the Free Speech Foundation CFO. Troy Brewer, via email on November 29, 2024.
- 8. In early May 2025 I was reviewing the annual reports for Naples Freedom Headquarters on the Florida Sunbiz.org website and noticed that on the Sunbiz filing of March 27, 2024, Dr. Simone Gold had been added to Naples Freedom HQ and a member. Dr. Gold has never been a member of NFHQ. I was always the sole member and manager. Shortly thereafter I followed up with NWRA and they were unable to either confirm or deny definitively that they had filed the erroneous annual report with Sunbiz in March of 2024. To the best of my knowledge and recollection it appears to have been a miscommunication between myself and NWRA as to how the erroneous report was filed with Sunbiz. We have since rectified the Sunbiz filing and are providing this declaration as evidence that this error was inadvertent and not a deliberate change.

I certify under penalty of perjury that the above statements are true and correct.
