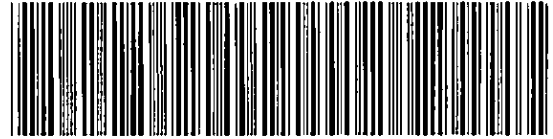




**ARTICLE III.
