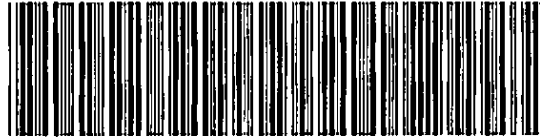

## **ARTICLE VIII - ADDITION OF NEW MEMBERS**

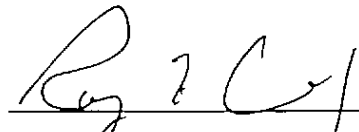
Additional members may be admitted by the unanimous consent of all members. If a new member or members are admitted, all members must agree upon the percentage ownership interest of each member.

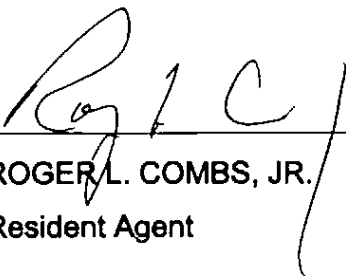

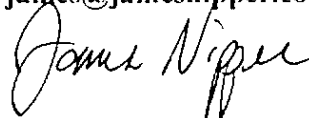
