**ARTICLES OF ORGANIZATION
OF

The undersigned, JESSICA WIMER, a natural person competent to contract and an authorized representative of JW Restaurant Group, LLC, hereby presents these Articles of Organization as the Articles of Organization of JW Restaurant Group, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is JW Restaurant Group, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The initial mailing address and initial principal address of the Company is 1110 North 9th Avenue, Pensacola, Florida 32501. The Company's mailing address and principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS

The date for commencement of the Company's existence shall be November 30, 2021. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.


ARTICLE V - REGISTERED OFFICE AND AGENT


