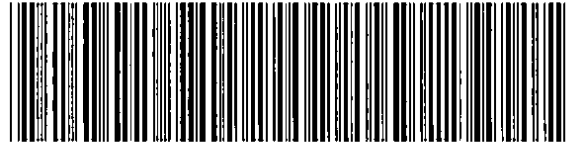


ARTICLE V – MANAGEMENT
