

ARTICLES OF ORGANIZATION OF DADAMIA LLC

The undersigned, Troy Stackhouse, competent to contract and an authorized representative of Dadamia LLC, hereby presents these Articles of Organization as the Articles of Organization of Dadamia LLC, a limited liability company formed under the provisions of Chapter 605, Florida Statutes.

ARTICLE I - NAME
