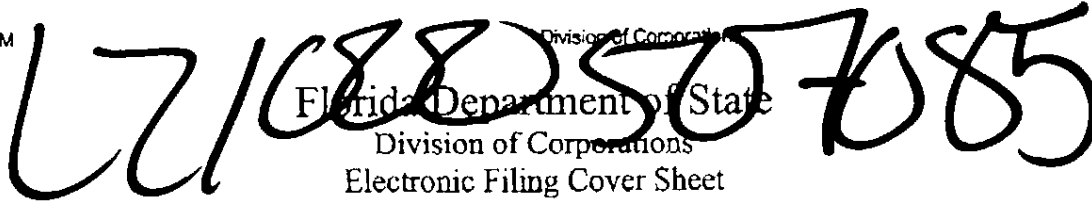

**ARTICLES OF ORGANIZATION
OF
DADAMIA LLC**

The undersigned, Troy Stackhouse, competent to contract and an authorized representative of Dadamia LLC, hereby presents these Articles of Organization as the Articles of Organization of Dadamia LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Dadamia LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE III - PURPOSE AND POWERS

The date for commencement of the Company's existence shall be November 30, 2021. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.


ARTICLE V - REGISTERED OFFICE AND AGENT


