**ARTICLES OF ORGANIZATION
OF

The undersigned, Andrew H. Harman, a natural person competent to contract and an authorized representative of a member of Camp Creek Lot 210, LLC, hereby presents these Articles of Organization as the Articles of Organization of Camp Creek Lot 210, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Camp Creek Lot 210, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The Company shall be managed by a manager in accordance with the terms of the Operating Agreement of the Company. The names and addresses of the initial managers of the Company are as follows:




